Located to the rear of the property. Privacy glass window to rear. Tile effect wet wall throughout. Chrome ladder radiator. Slate effect laminate flooring.

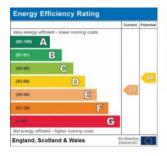
### Exterior

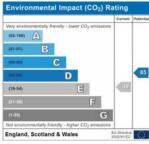
